Public Notice and Certification to Convene Virtual Board Meeting October 22, 2020

The Board of Commissioners of the Port of New Orleans have scheduled a Regular Monthly Meeting for Thursday, October 22, 2020. This meeting must occur in order to ensure continuity of business operations regarding time-sensitive action items for Board review and approval.

On March 11, 2020, the Governor of Louisiana issued <u>Proclamation 25 JBE 2020</u>, declaring a Public Health Emergency in response to the COVID-19 outbreak in Louisiana. The COVID-19 Public Health Emergency was subsequently extended by <u>Proclamation 135 JBE 2020</u>, to be effective through November 6, 2020.

The Board hereby certifies that in order to ensure the presence of a quorum of board members, which would otherwise not be possible under the present circumstances, it is necessary to conduct meetings on Thursday, October 22, 2020 in a virtual setting. The Board further certifies that the October meeting will be limited to one or more of the following: matters directly related to the Board's response to the current public health emergency, matters critical to the continuation of business, and matters that if delayed, will cause severe economic dislocation. Therefore, in accordance with La R.S. 42:17.1 et seq., and in consideration of the safety and wellbeing of the Board's members, staff, and communities directly impacted by the COVID-19 Public Health Emergency, the Board's October meetings will convene remotely, via videoconferencing.

Meetings will be livestreamed using the Zoom platform. Public comments will be accepted during the livestream through the Zoom Chat feature.
